

PARTICIPATION, PARENT/GUARDIAN ATTENDANCE & MEDICAL TREATMENT

I hereby authorise my child to participate in basketball and acknowledge that basketball is a fastmoving game and although categorised as a non-contact sport, incidents unfortunately do occur. I will endeavour to be present or ensure a responsible adult is present at all games, training sessions and other basketball activities in which my child is involved.

In the event of an emergency, I authorise the coach or team manager in charge to consent, where it is impracticable to communicate with me, for my child to receive such medical treatment as may be deemed necessary and I agree to bear any costs associated therewith.

INDEMNITY

I indemnify St Christopher's Junior Basketball Club, its volunteers, servants, and agents against all claims arising from my child's participation in the club's activities that are not covered by Basketball Victoria's insurance.
